## INVITATION TO BID FOR

### FARM INPUTS (HYBRID RICE SEEDS) FOR REGISTERED RICE FARMERS - MUNICIPAL-WIDE

The **Municipality of Burgos, Ilocos Sur**, through the **Virginia Tobacco Excise Tax (R.A. 7171)** under **Appropriation Ordinance No. 09-2023LBM86**, intends to apply the sum of **Php9,400,000.00** being the Approved Budget for the Contract (ABC) to payments under the contract, **Farm Inputs (Hybrid Rice Seeds) for Registered Rice Farmers – Municipal-wide, GDS 2024-025**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **Municipality of Burgos, Ilocos Sur** now invites bids for the above Procurement Project. Completion of the Works is required within **20 cds**. Bidders should have completed a contract similar to the project within three (3) years up to the date of bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184.

Interested bidders may obtain further information from the **Municipality of Burgos, Ilocos Sur** and inspect the Bidding Documents at the address given below during office hours from 9:00 AM – 4:00 PM.

A complete set of Bidding Documents may be acquired by interested Bidders on **April 17 – May 6, 2024** from given address and upon payment of the applicable fee for Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php10,000.00**. A non-refundable bidder’s fee in the amount of **Php5,000.00** shall also be paid to the Municipal Treasurer, Burgos, Ilocos Sur not later than the Opening of Bids. Official Receipts shall be presented in person as proofs of payments and for photocopying.

The **Municipality of Burgos, Ilocos Sur** will conduct a **Pre-Bid Conference on April 24, 2024**.

Bids must be duly received by the BAC Secretariat through manual submission on the office address as indicated below on or before **May 6, 2024, 2:00 PM**. Late Bids shall not be accepted.

All bids must be accompanied by a **Bid Security** in any of the acceptable forms and in the amount stated in **ITB Clause 15**.

**Bid Opening** shall be on **May 6, 2024, 2:00 PM** at the given address below. Bids will be opened in the presence of the Bidder’s representative/s who choose to attend the activity.

All bids (financial & technical documents) shall be submitted in three (3) sets. One Original and copies 1 & 2.


